## 3. OTHER TERMS AND CONDITION:

(a) The desirous and eligible candidates may send their applications in the attached proforma only by post to The Chief Administrative Officer (Senior Grade), ICAR- IIHR, Hesaraghatta Lake Post, Bengaluru-560089 inscribing on envelope "Application for the post of Full Time Medical Doctor"

(b) The application in the prescribed proforma with duly self-attested photocopies of Certificate of educational qualifications, experience, etc. should reach this office on or before <u>01.03.2025</u> before closing hours of the office. Late receipt of the applications will not entertained under any circumstances.

(c) Interview of the eligible candidates will be intimated at a later date.

(d) ICAR-IIHR, Bengaluru, will not be held responsible to give any regular appointment after expiry of the stipulated period of engagement.

(e) He/She will be paid fixed consolidated remuneration of Rs. 60,000/- only per month. No dearness allowance or any other type of allowance is admissible over and above the consolidated remuneration.

(f) That he/she should look after the efficient and proper running of the Institute Dispensary as regards to medicines, equipments and supervision of the work of the Dispensary staff is concerned.

(g) The candidate must be free from any legal proceeding/vigilance case and an undertaking to this effect is essential for undertaking this assignment.

(h) No vehicle or transport allowance will be provided for visiting the Institute and they make their own arrangements for reaching the office.

(i) That he/she should attend any employee of the Institute, if called for a special case outside the routine duty hours as referred above, he/she will be paid fee for this as per Medical Attendance Rule.

(j) That he/she should produce original certificates as regards to qualification, experience, no objection certification (if employed).

(k) The appointment shall be purely on contractual. In the event, if he/she desires to quit the

contract job or the Competent Authority not finding his/her services satisfactory, one month notice will be required to be given from either side. He /she will have no claim for continued employment in ICAR-IIHR, Bangalore. However, Director, ICAR-IIHR, Bangalore reserves the right to terminate the engagement without assigning any reason.

(1) Leave: He/She is eligible for 8 days leave in a calendar year on pro-rata basis. No remuneration for the period of absence in excess of the admissible leave will be paid to him/her. Un-availed leave shall neither be carried forward to next calendar year or it can be encashed.

(m) The appointment would be on full-time basis and he/she will not be permitted to take up any other assignment during the period of Contract in any other Department/Organization.

(n) He/she shall be bound to hand-over the entire set of records/equipment for the period of his assignment to the Institute before the expiry of the period.

(o) That if the declaration or information furnished by him/her proves to be false or found to have wilfully suppressed, he/she will be liable for removal from services immediately and other such action as may be deemed fit will be taken by the Competent Authority.

(p) Other conditions of the service will be governed by the rules and orders which may be issued from time to time by Indian Council of Agricultural Research, New Delhi.
