Sir,

Shri Ravinesh Kumar, Director, DARE and CVO, ICAR has vide his D.O. letter No. 39-8/2011-Vig. dated 18.6.2015 (available on ICAR's Website) drawn attention to the letters of the same number issued by Vigilance Division on 7.2.2012, 22.5.2012 and 27.2.2015. In these letters, the Vigilance Division of the Council has informed that in view of the instructions of DoPT dated 27.9.2011, Vigilance Clearance shall be denied to the officials who have not submitted their Annual Immovable Property Returns (AIPR) of a particular calendar year (i.e. as on 31st December) by 31st January of the following year.

Now, the CVO, ICAR has reiterated these instructions while mentioning that the vigilance clearance will only be issued to those officials who have submitted their AIPR for the Calendar Year ending on 31st December on or before 31st January of the following year. In this context, he has requested that the said instructions be scrupulously followed and the Head of the Office of the institute should be made responsible for compliance of these instructions in letter and spirit.

The SMD, therefore, requests all the institutes for compliance of these instructions and also sharing it with the Vigilance Officer of their respective institute.

I would like to draw your attention to the Council's letters of even number dated 07.02.2012, 22.05.2012 and 27.02.2015 wherein it was informed that in view of the instructions of DoPT dated 27.09.2011, vigilance clearance shall be denied to the officials who have not submitted their Annual Immovable Property Returns (AIPR) of a particular calendar year (i.e. as on 31st December) by 31st January of the following year.

It is once again reiterated that all the institutes must comply with Council's guidelines i.e. the AIPR pertaining to calendar year ending on 31st December should be filed on or before 31st January of the following year and the Vigilance Clearance will only be issued to those officials who have submitted their AIPR accordingly.

I would request you to personally look into the matter so that the said instructions are scrupulously followed. The Head of the Office of the Institute should be made responsible for compliance of these instructions in letter and spirit.
