NOTES:

1. It is the responsibility of the bidder to scrap the vehicles as per Transport Department(RTO) rule and not to use on road and IIHR is not responsible for anything.
2. Disputes arise if any shall be disposed off under Bangalore jurisdiction only.
3. The bidder shall have no objections for the officials of this Institute to carry out the research activities / farm operations of routine nature of the institute.

TERMS & CONDITIONS:

1. Interested parties/bidders may inspect the Tractors and Motor Cycle at this Institute on all working days between 10:00 AM to 5 -00 PM (except on Saturdays/ Sundays/ Closed Holidays/ General Holidays) with the permission of the In charge Farm Management Unit and Security of this Institute at IIHR,Bangalore.
2. *The tenderer is informed to quote their offer price in the prescribed format enclosed in FORM No.1.*The Committee will go for open auction cum sealed tender. The highest bidder among the sealed tender and open auction will be awarded subject to the reserve price and complying with the terms and conditions on point No:09.
3. **EARNEST MONEY:** The earnest money of **Rs.35,000/- (Rupees Thirty Five Thousand only) (The EMD details of individual vehicles are attached at Annexure-I)** should be deposited by the tenderer in the form of crossed demand draft in favour of The Director,ICAR-IIHR payable at Bangalore. The tender will not be considered if the earnest money deposit is not submitted with the tender. Request for consideration of adjustment transfer for any previous deposit of earnest money will not be entertained
4. The tenderer is informed to submit the tender paper along with EMD DD signing in all pages about acceptance of terms and conditions by **04/07/2024. THE TENDERS, WHICH ARE RECEIVED WILL BE OPENED AT 11.00 HOURS ON 05/07/2024** and open auction also will be conducted on the same time and date.
5. Open auction and sealed tender will be opened among the present representatives of the agencies participating in the tender process. The auction bid is to be held on **05/07/2024 at 11.00 A.M. in the office at Farm Management(Tractor Unit) .**
6. Only one authorized person per tender will be allowed to take part in the auction/tender process.
7. **MODE OF PAYMENT:** 25% of the bid/tender amount is to be paid by the successful bidder on the same day on which tender is opened and the balance 75% amount before taking of vehicles or within 04 days from date of auction. **Payment of the 25% and the 75% of the amount as required may be made through digital mode.** If the successful tenderer/auctioneer fails to comply with conditions stipulated above and at item No.10, she/he has to forfeit the deposited bid amount and the EMD.
8. **Any tax as applicable shall have to be paid by the successful bidder(GST /TDS).**

9. **Agreement & Security Deposit:** The successful tenderer should execute an agreement on a non-judicial stamp paper worth of Rs.100/- and also deposit 10% of the bid amount as security deposit within 4 days from the date of auction. The security deposit along with the EMD amount will be refunded only after the satisfactory completion of the contract, on receipt of written request thereafter.
10. The EMD of the unsuccessful tenderer will be refunded after the highest tenderer complete all the legal formalities mentioned in item No.09.
11. **Watch and Ward:** Watch and ward arrangement should be made by the successful tenderer immediately after the award of contract and the IIHR would not be responsible for the theft and damage by natural calamities or fire etc, thereafter.
12. Lifting of vehicle Process are to be carried out by the contractor or his labourers in the presence of our farm staff.
13. Farm operation required to be carried out will be continued and the contractor will have no right to interfere with the regular farm operations.
14. The successful tenderer must submit the name with full address and **photo copy of identity of required personnel to be engaged** in auction process and watch & ward purpose for entering the campus. Only those authorized personnel will be allowed inside the campus.
15. **The Director, ICAR-IIHR, Bengaluru will not bear any cost on account of salary and other allowance to the workers to be deployed by the Contractor.**
16. **The Director, ICAR-IIHR, Bengaluru will not be liable for any kind of damage, injury to the contractor or his labourer working in the Institute during the contract period.**
17. Advisory issued by the Competent Authority and/or Govt. of India from time to time may be complied by the Contractor/ his persons. Violation of advisory will attract termination of contract immediately.
18. Any loss, damage or pilferage of other property caused by him or his workers shall be personal responsibility of the tenderer/contractor, which will be recovered outright.
19. The Institute shall not be held responsible for any damage and or loss due to any climatic hazard, fire hazard or any natural calamity during the contract period and the tenderer is debarred from claiming refund of any amount, either in full or in part on these accounts.

20. The tenderer shall be personally and severally liable to compensate the loss or damage if any caused to any other assets of the Institute inside during completion of process within the contract period as would be assessed by the Director, and the same may be deducted from the refundable security deposit of the contractor
21. The Institute official and staff shall have the right to go round the spot to inspect the same and carry on such cultural operations as may be considered necessary by them or take observations during the contract period.
22. At the same time, Director will take appropriate action if peace and discipline of the campus are broken by the tenderer at any point of time during the auction period.
23. The responsibility of auction process rests with the tenderer.
24. **Lifting of vehicle /scrapping process should be completed on or before 20.07.2024.** However, if required this may be extended with prior approval of the Director. The tenderer and his personnel will leave the campus as soon as the tender period is over.
25. Firewood should not be used for cooking etc. in the orchard in any case. If any worker is found doing so the contractor will have to pay penalty fixed by the Director, ICAR-IIHR, Bengaluru.
26. **They should not carry any prohibited items into the campus.** The tenderer will be allowed to carry out his activities during the normal working hours of the Institute (10:00 A.M. to 5.00 P.M.)
27. In case of unavoidable circumstances viz., declared holidays, bandh, etc., the specified dates for various steps maybe extended to the next working day for which notice will be displayed only at our office premises.
28. **Arbitration:** In the event of any dispute of differences arising in connection with the tender, the same shall be referred to the Director, ICAR- Indian Institute of Horticultural Research, Bangalore. The decision of the Director, ICAR-IIHR shall be final and binding on the parties.
29. Notwithstanding the above, the undersigned reserves the right to accept or reject tender or annul the tendering process and reject all tenders at any time prior to award of the contract, without assigning any reason, whatsoever and without incurring any liability of obligation, whatsoever, to the affected tenderer or tenderers.

30. No child labour shall be engaged for the said work, and the Institute will not be responsible for any loss or damage in transit. Insurance if any required has to be done by the contractor at his own cost. The successful bidder shall pay all compensation etc including accident compensation due to their labourers. The Institute will not be responsible for any claim by the labourers engaged by the firm/successful bidder.
31. The bidders/ tenderer violating any of the above terms and conditions would stand to forfeit the bid amount and the Director reserves the right to dispose the trees through other agencies. No complaints would be entertained in this regard.
32. The successful bidder shall arrange his own labours, transportation /implements of removal / collection of tractors & vehicles
33. **The successful Bidder has to collect the gate pass from the In-charge, Security from the main gate & the permission of the Nodal Officer(FMC) has to be obtained for entering the premises of the Institute each time till the completion of work.**
