1. The Contract shall be for the whole works as described in the specifications.

  - d. GST returns for six months(July to December,2023).
3. All duties, taxes and other levies payable by the Contractor under the Contract shall be included in the total price.
4. The Rates quoted by the Bidder shall be valid at least for a period of not less than 90 Days.
5. The rates quoted by the bidder shall be fixed for the duration of the Contract and shall not be subject to adjustment on any account.
6. The bidder is advised to visit the site of works at his own expenses and obtain all information that may be necessary for preparing the quotation.
7. **Each Bidder at Annexure-II shall submit only one Quotation. Bids shall be accepted from the attached vendor list only (Annexure-II).**
8. No advance or part payment will be given. Payment will be arranged only after Satisfactory completions of the work duly certified by the works unit of IIHR.
9. Quotations should be submitted along-with Earnest Money Deposit (Interest Free) of **Rs.10,600/-** for the above item by way of Demand Draft drawn in favour of the Director, Indian Institute of Horticultural Research, Bangalore 89. Quotations without EMD or insufficient EMD will not be considered. The EMD will be liable to be forfeited, if the Contractor/Agency withdraws or amend, impairs, or derogates the Quotation, in any respect within the period of validity of this Quotation. .
10. **No EMD exemption is given for MSME/ Udyog Aadhar or NSIC and other firms**

11. EMD of unsuccessful agency/contractor (except L1, L2 & L3) remitted in the form of DD will be returned to the concerned contractor without any interest thereon, as early as possible.
12. The firm, to whom the tender will be awarded, will have to deposit the **performance security equal to 5% of the total quoted amount at which the Tender will be awarded within 21 days from the date of completion of work in the form of DD /Bank Guarantee and the same will be retained during the Defect liability period(warranty) of One year. In the sense, for any material and execution defects, the firm has to set right the defects within 10 working days and maintain the said work.** If the services are not found to be satisfactory, the performance security is liable to be forfeited. No interest will be paid on performance security.
13. Income tax / GST / TDS will be deducted from the bill of the executing agency / contractor as per Govt., Rate.
14. **Duration of work should be completed within sixty days from the date of issue of work order** and beyond to that Penalty will be imposed at 0.50% per week maximum to 10% of the total cost of work, if works are not completed within scheduled item or mutually extended period. The Director, IIHR, may cancel the contract and take recourse to such other action as deemed appropriate once the total amount of liquidated damages exceeds 10% of the contract amount.
15. **The Bidder may please note that, the executed work must have a defect liability period (DLP) of 12 months from the date of completion of work.**
16. The Director, ICAR-IIHR, shall have the right to reject all or any of the offers, accept more than one offer, and assign part of the job without assigning any reason.
17. Merely quoting of lowest rates does not mean that order shall be given to that firm. The competent authority will finally decide on the basis of quality & performance of past installations.
