3. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Council reserves the right to accept or reject any or all the tenders.
4. The interested Firms are required to deposit (in original) **EMD of Rs.25,000/-** in the shape of Demand Draft in favour of **THE DIRECTOR, ICAR, UNIT-IIHR payable at Bangalore** may be address to **Asstt. 1. The tenderer shall quote rates.GST, Freight charges if any, should be indicated separately.
2. The rates should be quoted as per the BOQ uploaded on the CPP Portal (reference may be obtained from Annexure-III). GST, if any, should be indicated separately. It must be noted that the contract shall be awarded to the firm which fulfils all the required terms and conditions and remains L-I for any particular items.
3. The firm must also possess valid PAN No. & GST registration number and a copy of the same must also be enclosed with the tender document.
4. Copy of Financial year 2015-16, 2016-17 & 2017-18 or 2016-17, 2017-18 & 2018-19, Income Tax Statement may be furnished.
5. The firm should be in existence for over 05 (Five) years in the trade with the business turnover of not less than Rs.30 Lakhs per annum for 2015-16, 2016-17 & 2017-18 or 2016-17,2017-18 & 2018-19.Chartered Accountant certified profit and Loss account, Balance sheet to this effect may be enclosed.
6. Modification in the tender documents after the closing date is not permissible.
7. The successful firm shall have to supply the **Micromanipulator with Microinjection Facility with Accessories – 01 no.** within 20 days from the date of confirmed supply order and if the materials are not supplied in time then EMD shall be forfeited. 9. The Director, ICAR-IIHR, shall have the right to reject all or any of the offers, accept more than one offer, and assign part of the job without assigning any reason.
10. Merely quoting of lowest rates does not mean that order shall be given to that firm. The competent authority will finally decide on the basis of quality & performance of past installations.
11. The interested Firms are required to deposit (in original) an **Earnest Money Deposit of Rs.25,000/-** amount mentioned against item in the form of Demand Draft from any of the Commercial Bank in favour of **THE DIRECTOR, ICAR, UNIT-IIHR payable at Bangalore** may be address to **Asstt. 12. Rates once finalized will not be enhanced/reduced during the currency of the contract.
13. In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded, for whatsoever reason(s), to honour the contract, the earnest money /performance security deposited would be forfeited.
14. The Director,ICAR-IIHR reserves the right to cancel the contract at any time during the currency period of the contract without giving any reason.
15. The firm, to whom the tender will be awarded, will have to deposit the performance security equal to 3% of the total amount at the time of installation of equipment. If the services are not found to be satisfactory, the performance security is liable to be forfeited. No interest will be paid on performance security.
16. If any dispute(s) arises between IIHR and the firm with reference to the contract, IIHR will decide it and its decision will be binding on the firms.

18. Bid Validity: 180 days
19. The contract will be given to item-wise least one (L1).
20. Our Institute is registered with DSIR and we are exempted from Excise Duty & Custom Duty. Hence CDEC/DSIR will be provided to the firm, if demanded. Rate should be quoted accordingly.
21. Payment:-
- a) Payment for goods supplied from abroad
- i) On shipment 90% of the contract price (FOB) shall be paid through irrevocable letter of credit upon submission of documents detailed in L/C.

22. Installation:- Within **20 days from the date of receipt of equipment** in the Institute failing which Liquidated Damage clause shall apply.
Liquidated Damage clause: It would be realized @ 0.5% (half per cent) of the base price (excluding taxes) of the delayed goods for each week of delay subject to maximum 20%.
23. Prices:
- i. Price to be quoted in Foreign Currency CIP, Bengaluru Airport and to be delivered @ IIHR Hesaraghatta, Bangalore.
- ii. If any bidder wants to quote in INR, price be quoted on FOR, IIHR, Hesaraghatta, Bangalore basis.
- iii. In case the stores pertain to Import:
- a) Kindly ensure to enclose manufacturer's authorization in favour of Indian subsidiary firm. It may also be noted that further authorization by subsidiary firm in favour of any other firm located in India to promote their sale must have authorization from the Principal firm for further authorization to an Indian firm, failing which the tender is liable to be cancelled.

INSTRUCTIONS FOR ONLINE BID SUBMISSION

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at <https://eprocure.gov.in/eprocure/app>.

REGISTRATION

- Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL <https://eprocure.gov.in/eprocure/app>.) by clicking on the link '**Online bidder Enrollment**' on the CPP Portal which is free of charge.
- As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (class II or Class III certificates with signing key usage) issued by any certifying authority recognized by CCA India (e.g. Sify/nCode/eMudhra etc.) with their profile.
- Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- Bidder then logs in to the site through the secured log-in by entering their users ID/password and the password of the DSC/e-Token.

SEARCHING FOR TENDER DOCUMENTS

- There are various search options built in the CPP Portal. To facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS/e-mail in case there is any corrigendum issued to the tender document.
- The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.

PREPARATION OF BIDS

- Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in

which the bid documents have to be submitted, the number of documents- including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLS/RAR/DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use 'My Space' or 'Other important Documents' area available to them to upload such documents. These documents may be directly submitted from the 'My Space' area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other technical issues.
- The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- Bidder has to select the payment option as 'offline' to pay the tender fee/EMD as applicable and enter details of the instrument.
- Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- Bidders are requested to note that they should necessarily submit their financial bids in the Format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cell with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric, encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.

Technical Specification for Micromanipulator with Microinjection Facility with Accessories - 1 No

- The system should be a fully electronic system and all X, Y, Z axis movements are controlled electronically.
- All three axis movements at all speed control should be controlled with one single integrated joystick. The system should have the coarse, fine, extra-fine movement selections using a single upright joystick.
- The system should have resolution of not more than 0.025 μm (25 nm) increment for fine and smooth movement.
- The system should have maximum travelling distance of 15mm in all three axis.
- The system should have a joystick for dynamic movement: the speed of the capillary is increased by the degree of joystick deflection.
- The system should be capable of aligning the capillary at from 0 degrees upto 90 degrees for completely side-on injections.
- The system should have a tool travel speed of at least 0 - 9000 $\mu\text{m/s}$, for rapid work and penetration of tough material.
- The system should have option to set both upper & lower programmable Z axis limits for effective injection.
- The system should have position save option, at least 2 positions which can act as a search plane for the easy searching of cells.
- The system should have an automated function for the capillary to move out of working radius and return to the precise same spot, called “home” (For easy capillary replacement) and “Clean” (To clean the debris) functions.
- The system should be able to connect to an electronic microinjector to carry out semi-automated axial injection where penetration of cell and dispensing of sample is performed automatically and optional foot paddle to trigger manual injection.
- The system should have an option to connect to a piezo device and the piezo impulses can be supported by adjustable automated forward movements.
- The manipulator should not have handedness and it should be possible to mount it on either side of any Microscope.
- Featuring a wide range of functionality, simple operation and built-in compressor or additional cylinder with regulator to independently deliver the required pressure.
- Ideal for applications Pronuclear or cytoplasmic injection of RNA/DNA solutions into fertilized oocytes of animals/insects. Injection volumes range from femtoliters to microliters
- Programmable injection ensures reproducibility.
- User-friendly interface with large LCD for easy operation.
- System should be optimized user interface for various applications.
- The electronic microinjector should have programmable parameters like injection time, injection pressure, compensation pressure.
- Should have both injection pressure and compensation pressure range between 10 – 5000 hpa.
- System should have clean function and the rinsing pressure range 5000hpa.
- System should have serial interface RS-232/USB for future software updates.
- Should supply the appropriate sterile injection capillaries and sample loading tips.
- Should supply the universal stand or suitable adaptor to mount the micromanipulator independently
