INSTRUCTIONS FOR ONLINE BID SUBMISSION

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at <https://eprocure.gov.in/eprocure/app>.

REGISTRATION

- Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL <https://eprocure.gov.in/eprocure/app>.) by clicking on the link '**Online bidder Enrollment**' on the CPP Portal which is free of charge.
- As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (class II or Class III certificates with signing key usage) issued by any certifying authority recognized by CCA India (e.g. Sify/nCode/eMudhra etc.) with their profile.
- Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- Bidder then logs in to the site through the secured log-in by entering their users ID/password and the password of the DSC/e-Token.

SEARCHING FOR TENDER DOCUMENTS

- There are various search options built in the CPP Portal. To facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS/e-mail in case there is any corrigendum issued to the tender document.
- The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.

PREPARATION OF BIDS

- Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in

which the bid documents have to be submitted, the number of documents- including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLS/RAR/DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- To avoid the time and effort required I uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use 'My Space' or 'Other important Documents' area available to them to upload such documents. These documents may be directly submitted from the 'My Space' area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- Bidder should log into the site wll in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other technical issues.
- The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- Bidder has to select the payment option as 'offline' to pay the tender fee/EMD as applicable and enter details of the instrument.
- Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- Bidders are requested to note that they should necessarily submit their financial bids in the Format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cell with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric, encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.

TECHNICAL SPECIFICATIONS FOR VIDEO DOCUMENTARIES ON IIHR**TECHNOLOGIES RELATING TO FRUIT AND VEGETABLE CROPS - 07 NOS.**

* ICAR-IIHR, Bengaluru has developed more than 200 varieties of fruits, vegetables, flowers and medicinal crops and over 100 technologies and commercialized many of them. These varieties and technologies have been successfully adopted by several farmers and entrepreneurs across the country. It is proposed to video document the success stories of these enterprising farmers and entrepreneurs and distribute to over 800 *Raitha Samparka Kendras* in Karnataka. Under this project, it proposed to video shoot the technology adoption in farmers fields spread across different locations in the states of Karnataka, Tamil Nadu, Telangana, Andhra Pradesh and Kerala. Tenders are invited from interested firms to undertake the following items of works (shooting, editing, voice dubbing / commentary, sub-titling, multiple DVD copying, etc.). The detailed items of work, eligibility, etc., furnished below.

1. Production of 07 nos of video documentaries on the following IIHR Technologies each of one hour duration to be shot at different location in the Southern India.
2. List of different video documentaries to be produced are given below:

I Fruit Crops

1. About ICAR-IIHR 53 years of achievements- glimpses
2. Documentary on Mango, Guava and Papaya
3. Production technologies of Arka Sahan, Grapes – root stocks, budburst..
4. Future fruit crops : Dragon fruit, Avocado and Fig
5. Linking biodiversity through livelihood security
6. High density of Mango

II Vegetable Crops

1. ICAR-IIHR Tomato, Onion and Chillis: Production hints, Farmers opinion and Success Stories
 2. Production hints of vegetable varieties
 3. Protected cultivation of vegetables
 4. Organic cultivation of vegetables: (3 to 4 crops, inputs, bio-pesticides, AMC, Traps, Soaps)
3. Editing each of the above documentary videos to 15-20 min duration.
 4. Adding voice track (commentary) **in Kannada by professional dubbing artist**. Material for voice track will be provided by the Institute.
 5. Adding sub titles in Kannada wherever the successful farmers or entrepreneurs or technology adopter speaks in a language other than Kannada.
 6. Punching or copying each edited video, complete in all respects in to 800 copies of DVD's (07 videos X 800 = 5600 DVD's).
 7. Each DVD should have label (Printed Multicolour) and should be supplied with case.

8. 1. The successful bidder has to handover the master copy of 1 hour shooting of all the 07 technologies along with master copy of edited version (15-20 minutes) besides the 800 copies of each video documentary.
2. The successful bidder should employ/ use minimum 4K resolution camera. The camera, assistant's helpers and other accessories has to be arranged and borne by the bidder.
3. The location of shoot could be at different places/ farmers field in southern India. Transportation from Bengaluru to shooting location will be arranged by the institute.
4. The entire work starting from shooting to handing over of finished product as indicated at (2) above should be completed within 30 days from the date of issue of work order/ purchase order.
5. The Nodal Officer nominated by the institute will liaise with the selected firm from inception till completion of the work.
